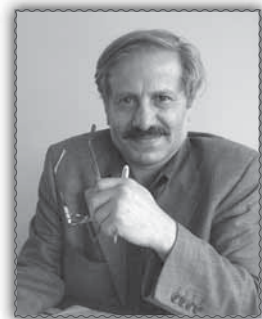
Now its the grand responsiblity of veterinary organization to evaluate the situation scyentific and technical to prevent the predicted events and irreparable losses.
